- (3) Report from Lynda Lyter from the Dept. of Administration pept. of provided information to the membership Administration regarding SB 700. This affects the manner in which telephone bills are paid. All phone bills will be processed through IS&C, and agencies are to pay IS&C with an IGT within thirty (30) days. Agencies are to send IS&C a telecommunications log along with the phone bill.
- (4) Inquiry
 Regarding inquired as to whether boards could be procedural provided with model procedural rules drafted by the Office of the Attorney General with regards to holding open meetings.
 Representatives from the Attorney General's Office who were present indicated that this issue will be taken under consideration, and that any issue common to all boards can be brought to that office for discussion.
